

**PREAMBLE AND PROCEDURE**  
**SOUTH CAROLINA SINGLE SIDEBAND NET**

1. This is YOUR CALL , net control calling "CQ" to the SOUTH CAROLINA SINGLE SIDEBAND NET. My name is YOUR NAME and I am in YOUR TOWN . This net meets on 3.915 MHZ at 7:00 PM local time, and all amateurs licensed to operate on this frequency are invited to participate.
2. LIAISON STATIONS, Please check in now.
3. Stations with traffic going OUT OF STATE, please check in now and list what you have. Any other OUT OF STATE TRAFFIC?
  - A. Handle out of state traffic on frequency and release LIAISON STATION
4. Stations with TRAFFIC COMING INTO SOUTH CAROLINA FROM OUT OF STATE, please check in now and list what you have.
  - A. If traffic is listed and a station is not available in the destination location, NCS is responsible for accepting for relay or designate the same. The Key is to take the traffic from the Out Of State Station.
  - B. Release the station after receiving the traffic.
5. Are there any MOBILE STATIONS waiting to check into the net?
6. Stations with FORMAL TRAFFIC, BULLETINS or ANNOUNCEMENTS, please check in now and list what you have. Any other TRAFFIC, BULLETINS OR ANNOUNCEMENTS?
  - A. Handle ANNOUNCEMENTS and BULLETINS on frequency.
  - B. Handle FORMAL TRAFFIC. (On frequency unless it will hold up the net for too long).
7. This is a DIRECTED NET—ALL STATIONS please DIRECT ALL COMMENTS to the NET CONTROL STATION, check in your proper alphabetical group, list any INFORMAL TRAFFIC and indicate if you will remain for the RAG CHEW part of the net. Please REMAIN ON FREQUENCY UNTIL THE LIAISON STATION RETURNS, in case there is traffic for your area.
8. This is DAY OF WEEK and the roll call begins with MATCH GROUP WITH DAY OF WEEK.

(Sun A\_D) (Mon E\_H) (Tue I\_L) (Wed M\_P) (Thr Q\_T) (Fri U\_Z) (Sat A\_D)

- A. Check to see that all business for the net has been handled.
- B. Announce the END of the formal part of the net and excuse stations not staying for RAG CHEW.
- C. Handle short informals on frequency and invite stations with "long ones" to find another frequency.
- D. Proceed into RAG CHEW, PAUSING AT INTERVALS TO CALL FOR ADDITIONAL CHECKINS.
- E. Thank the stations who participated in the net and announce the closing of the net at the appropriate time.

If needed, NET CONTROLS should appoint one or two RELAY stations and CALL on them to keep confusion to a minimum.

**IT IS THE RESPONSIBILITY OF THE NET CONTROLS TO NOTIFY AN ALTERNATE OR THE NET MANAGER IF THEY WILL BE UNABLE ON THEIR NIGHT TO CALL THE NET.**
